#### BACKGROUND

The Pakistan Horticulture Development & Export Company (PHDEC) intends to shift its office to 1154 Sq. Ft. space at Ground Floor, SLIC building No.5, China Chowk, Blue area, Islamabad. In order to carry out miscellaneous Renovation and Interior Work in the said Office Space, PHDEC requires the services of firms/ companies registered with Pakistan Engineering Council in relevant category and duly registered with Income Tax and Sales Tax and are on Active Tax Payers' List of FBR. As-Built plan of Ground Floor, SLIC building No.5 is attached at **Annex-I**.

#### SCOPE OF SERVICES

The selected firm will be required to provide following services:

- *i.* To develop an architectural design with detailed drawings as per approved layout of the space and develop following facilities for the office accommodation:
  - a. One Meeting Room
  - b. Ten (10) offices for Officers/officials
  - c. store/photocopy area
  - d. Kitchen area
  - e. Washrooms renovation
  - f. False Ceiling
  - g. Carpeting
  - h. Record room Shelves
- *ii.* To carry out the necessary Renovation and Interior Works for developing office space as per requirement given above.

### **Procedure of Competitive Bidding**

Single Stage – Two envelope procedures, as per rule no. 36 (b) of Public Procurement Rules, 2004, will be followed as per following:

I. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. II. The envelopes shall be marked as **"FINANCIAL PROPOSAL**" and **"TECHNICAL PROPOSAL**" in bold and legible letters to avoid confusion.

#### Submission and Opening of Bids

Bidding Document duly filled and complete in all respect along with all the requisite document and information can be submitted on **28**<sup>th</sup> **April**, **2023** by 11.00 am. The bids will be opened on the same date at 11.30 am on the address given in the tender notice as per Rule No. 28 (2) of PPRA 2004.

Selected firm must complete all tasks **within 15 days**.

#### **Bid Security**


All the Bidders are required to submit 2% bid amount of the total bid in the form of Pay Order/ Demand Draft in favor of Pakistan Horticulture Development & Export Company (PHDEC), Islamabad shall be submitted with the sealed '**Financial Proposal**' as per Rule No. 25, Public Procurement Rules, 2004. Bids without bid security will be rejected.

#### Payment Schedule

The successful bidders will be required to carry out the work as per BOQs. The firm can claim the payment upon completion of work as a whole/ completion of any specific/ individual segment as a whole as per BOQ. All the payments will be made on actual basis/ work done as per rates quoted in financial bid and after issuance of work completion certificate and satisfaction of the Authority. The Authority will not make any payment against incomplete/ non-satisfactory work.

No advance payment will be made. Retention money of 10% will be retained for each invoice claim. Retention money will be released after three months of completion of work.
