RUSSIAN RICE MARKET REPORT

I. INTRODUCTION

By the end of 2023 the situation on the global rice market remains difficult. Crop failures in many producing countries and customer demand are pushing prices up. The situation is also heating up with the ban on rice exports that has already been introduced by several countries including India, Russia, and the United Arab Emirates. According to the Fitch Agency, in 2023-24 the global market faces the maximum rice shortage in 20 years.

Rice is one of the most important grains on the planet, it feeds more than 50% of the world's population. It is consumed daily by majority of residents of China, Vietnam, Pakistan, Myanmar, India, Thailand and many other countries. Over 70% of global rice production is accounted for by five countries: China, India, Indonesia, Vietnam and Thailand.

Pakistan, India, Thailand, Vietnam and the USA grow and export most of all. Rice is produced but mainly goes to the domestic market in Indonesia, Bangladesh, Myanmar. China despite its huge own production (145,946 thousand metric tons in 2022-23) exports comparatively small volume of rice (2,200 thousand metric tons), being the world's largest importer of rice. The major buyers of rice in the world are Saudi Arabia, Iran, the United Arab Emirates, Europe and the United States.

II. INDIA'S EXPORT BAN

India is the world's main producer and exporter of rice. Indian rice occupies about 40% of the global market. On September 9, 2022 India imposed a 20% duty on the export of certain types of rice banning the supply of broken rice and also

imposed a 20% duty on the supply of white and brown rice which account for about 60% of India's global sales. Parboiled rice and basmati did not fall under the restrictions as Directorate General for Foreign Trade of India reported.


In July 2023 India entirely banned the export of all kinds of rice except for basmati and parboiled white rice. The government decided to keep local prices, which have already increased by 15-20%, as low as possible and prevent a shortage of rice within the country. In October 2023 the ban was extended until March 2024, and it is likely that it will be extended further.

Analysts considered that India's decision would cost it dearly as it would deprive the country of market share. The point is that rice buyers may switch to Vietnam, Thailand and Pakistan which are the next largest exporters of this crop. Pakistan being the fourth largest exporter of rice in the world can also take advantage of the situation.

IV. RUSSIA'S RICE EXPORT BAN

The rice export ban was initiated in July 2022 after the accident at the Fedorovsky hydroelectric complex in the Krasnodar Territory which left half of the acreage without irrigation. It was supposed to eliminate the risks of shortages and ensure stable prices for finished products for consumers. But the ban was extended after the elimination of the consequences of the accident, the last time - until December 31, 2023. At the end of November 2023, the Russian Ministry of Agriculture proposed to extend the export ban for another six months, until June 30, 2024. The decision has still not been taken.


Prior to the Russian export ban and according to the earlier concluded contracts Russian rice export in 2022 was on the par with 2021. The data for 2023 is not available so far which will probably witness a major slump in the Russia rice exports.

V. PAKISTAN'S RICE EXPORT TO RUSSIA

In 2022 Russia imported rice to the amount of US\$ 118.45 million from all over the world. Imports of rice grew by 20.37% percent from US\$ 98.40 million in 2021. India is the main supplier of rice to the Russian Federation in previous years but its share has reduced from 70.76% in 2021 to 42.82% in 2022 but still is the biggest rice exporter to Russia. Kazakhstan remained the second biggest exporter of rice with significant increase in supplies to raise its share in the overall rice

export from 12.49% to 23.35%. There are still doubts about the origin of Kazakhstan's rice as the country is number one route for so-called "parallel" or "grey" imports to Russia including food. On top of all Kazakhstan suffered from drought recently which affected the harvest volume.

Most of Pakistani rice is also finding its way to the Russian market after customs clearance in Kazakhstan (Shymkent) and also in Kyrgyzstan (Bishkek) - previously due to the rice import ban on Pakistani companies and now due mainly to bank transfer issue. However, the exact data of Pakistani rice destined for Russia is not available. TIC. Kazakhstan has been requested time and again to provide the data to make a correct analysis but so far no success on this account. However, due to ease of customs clearance in Kazakhstan and lesser sanitary and phytosanitary controls and ease of payments, Pakistani rice is being shipped to Russia mainly via Kazakhstan and also from Kyrgyzstan, but is being reported as exports to Kazakhstan and Kyrgyzstan.

Another reason for performing customs clearance in Kazakhstan and Kyrgyzstan is that the eligible exporters to Russian market being the biggest in the trade are shying away from exporting to Russia owing to their bigger market share in Europe and USA. The rice from those establishments which are not allowed to export to Russia are sending their shipments via the two countries mentioned above.

Pakistan has shifted from its fifth place in the rice supplies to the Russian Federation with the share of 2.47% in 2021 to the sixth place with the share of 1.5% in 2022.

According to the State Bank of Pakistan statistics exports of rice from Pakistan to Russia increased from US\$ 0.05 million in 2021 to US\$ 7.042 million in 2022 showing a growth of 13 984%. The latest statistics from the State Bank of Pakistan for July-June 2023 (4 Quarter FY2023) for rice exports from Pakistan to Russia shows a slump of 6 187% down to US\$ 0.117 million from US\$ 7.042 during the same period of 2022.

As is clear from the above statistics of rice supplies from Pakistan to the Russian Federation in 2020 there was a drastic decrease in supplies due to the

introduction of the ban on the supply of Pakistani rice to the Russian Federation due to the phytosanitary requirements, described below, in May 2019.

Due to the concerted efforts to lift the rice import ban since 2019 as of now, 24 rice establishments are allowed to export rice. During the last one and the half year as many as 20 rice establishments were allowed by FSVPS. It is expected that the rest of companies will also be allowed by the Russian NPPO after duly considering the documents submitted last month for that purpose.

VI. RUSSIA'S BAN ON IMPORT OF RICE FROM PAKISTAN

On May 18, 2019 the Federal Service for Veterinary and Phytosanitary (FSVPS) imposed a ban on the import of grain and grain products from Pakistan to the Russian Federation due to the presence of a quarantine object i.e. Capri beetle (Trogoderma Granarium Ev) in a living state in a consignment sent to the Russian Federation. Department of Plant Protection, Ministry of National Food Security & Research was duly communicated. In response, the DPP / NPPO, Pakistan investigated the matter and shared the findings of the investigation and informed that it suspended the responsible rice processing and production site / exporter and treatment provider and removed their names from the approved list of exporters.

In June 2021 after prolonged and consistent efforts of this Mission and authorities back home FSVPS lifted ban on four rice establishment namely: M/s Garibsons (Pvt) Ltd, M/s Matco Foods Ltd, M/s Guard Agri Research & Services (Pvt) Ltd and M/s Iqbal Rice Mills (Pvt) Ltd. In September, 2022 the matter was again vigorously taken up with FSVPS that resulted in lifting of ban on another company namely M/s Meskay & Femtee (Pvt) Ltd along with provision of a detailed dossiers of 12 establishments for Pakistani authorities to remove observations and prepare for video inspection of 15 establishments.

In June 2023 FSVPS agreed to lift ban on 14 rice establishments and in another meeting on 04.09.2023 FSVPS has further agreed to lift ban from another 05 companies thus bringing the total number of companies eligible to exports to Russia to 24.

The communication with FSVPS is still in progress and will continue in 2024. This is highly alarming and requires intervention from all stakeholders including MoC, REAP, etc. keeping in view the fact that the number of eligible companies has increased coupled with temporary ban by India on rice export. It is expected that the exports to Russia, if not surpassed, are restored to the previous level at least.

VII. RICE IMPORT DUTY AND REQUIREMENTS

All HS Codes of rice while importing to Russia fall under the same import duty and requirements which is 10% duty, but not less than 0.03 euro/kg plus 10% VAT. The same import duty applies to the supplies of rice to EAEU. According to FTA between EAEU and Vietnam the country may export up to 10 thousand tons annually with customs duty of 0%. Above this volume the general 10% duty is applied. Never the less Russia may impose so-called sanitary protective measures to cover the local market, increase local production or use it as a political counterblow.

Import Quarantine Permits by FSVPS - determine the requirements and conditions for the import and phytosanitary certificates of the exporting country (an international document issued by the quarantine and plant protection authorities of exporting countries, attached to accompanying transport documents)

are presented only to the State Inspectorate for Plant Quarantine at checkpoints when importing goods into the customs territory of the Russian Federation. They are not required for customs clearance.

VIII. CONSUMPTION IN RUSSIA

Rice occupies a small place in the diet of Russians. For comparison: a resident of China consumes 126 kg of rice per year, a resident of Russia - up to 8 kg in 2023. The total consumption of rice in Russia is 1,190 thousand tons per year whereas imports accounts for not more than 25-30% totally. The latest statistics shows that the consumption of rice in Russia will be growing.

IX. GROWING RICE IN RUSSIA

Russian rice production set an all-time record in 2023. According the Russian Institute for Agricultural Market Studies (IKAR) 475 thousand tons of rice were produced in Russia for the latest 10 months (25 thousand tons more than in the same period last year). In comparison with the same period 10 years ago, the production of rice increased almost 1.7 times. Russian rice also increased its quality which was welcomed by the local and export markets. The saturation of the market with domestic rice will remain at a high level throughout the processing season 2023/24.

In Russia, rice cultivation is complicated due to climatic and geographical conditions. Rice in Russia is grown mainly in the Krasnodar Territory (Kuban), as well as in the Rostov region (both the South of Russia) and in the South of the Far-Eastern part of the country (Primorie Region). Among the three rice producing areas Kuban accounts for more than 80% of all rice production in Russia.

Experts believe that the ban on Indian rice exports will not affect the Russian market greatly, as supplies from Vietnam, Thailand and Pakistan can be increased and they do. In neighboring Uzbekistan and Kazakhstan in 2023, rice harvests were smaller than expected due to lack of water supplies.

X. PRODUCER AND RETAIL RICE PRICES

Following India and UAE, Russia imposed a ban on rice exports on July 1, 2022. As a result, rice prices in Asia rose to the highest level in several years. In Thailand five percent crushed rice export price rose to \$659 per ton, in Vietnam reached \$600 per ton.

Against the background of high local supply, producer prices for rice in Russia began to decline: in October 2023 a ton of rice cost 81,800 rubles (US\$ 894.77), then by the end of November 2023 the price dropped to 79,080 rubles (US\$ 865.01). In December 2023 rice prices in Russia are declining due to the large harvest.

According to the Russian Statistics Bureau (Rosstat) in December 2023 the retail price for white crushed rice in Russia stand at 122.56 rubles (US\$ 1.34) per kg which is 10.32% more expensive than December 2022's price - 111.09 rubles (US\$ 1.22) per kg.

Basmati rice being not very popular in Russia is not considered in Rosstat statistics as it traces only basic products prices. However, in the Food City, being the largest wholesale as well retail market in the whole region, the price of 5 kg basmati rice changes from 200 – 240 rubles (US\$ 2.20-2.60), whereas in retail chain stores the price is higher and varies from store to store. The average landing price (including freight, customs clearance other charges, etc.) per ton of Irri-6 in Russia is around US \$ 1100-1120 whereas the basmati price range between US \$

1050-1000. However, the demand of non-basmati white rice is much higher as compared with basmati rice (it is around 10:1 container in general). Due to recent rice bans, there is huge scope of rice exports to the Russian
